#### ACTUARIAL VALUATION OF POST EMPLOYEE BENEFITS IN TERMS OF GRAP 25

#### 1.1. Introduction

Bids are hereby requested for quote to perform the liability in respect of the post- employment medical aid subsidy to employees and retirees of Elias Motsoaledi Municipality and to their registered dependants.

The purpose of this evaluation is to enable the Municipality to provide appropriate disclosure in the Annual Financial Statements

#### 1.2. Scope of Valuation

The effective date of the valuation is the 30 June 2019

The valuation considers all employees, retirees and their dependants whose participation in the health care arrangements entitles them to a post-employment medical aid subsidy. The post-employment health care liability is not a funded arrangement that is not a separate asset that has been set aside to meet this liability.

There are approximately **three hundred and forty three (343)** employees and the number exclude **sixty four (64) Councillors** 

The number of retirees and their dependents is **twenty (20)** and also requested is the actuarial valuation of its liability in respect of Long Service Awards to employees. The effective date of the evaluation is 30 June 2019

The valuation considers all employees eligible for Long Service Awards "LSA" and post-employment medical aid subsidy. The Municipality will provide the data for this valuation.
