Quotations are hereby invited from service providers to:

- Providing a Landfill Compactor or Chained Bulldozer to compact and Clean **HLOGOTLOU TRANSFER STATION** eight (8) hours per day for five (5) days, or lesser days
- Administer Pesticides for Rodents and Rats within **HLOGOTLOU TRANSFER STATION**.

The municipality shall adjudicate and award quotation in accordance with the preferential Procurement Policy Framework Act. 5/2000 and the revised Preferential Procurement Regulation as amended June 2011 on 80/20 points system where 80 points are for the price and 20 points for B-BBEE according to the said legislation.
