1. Introduction

The Development Planning and Local Economic Development Directorate of Elias Motsoaledi Local Municipality requests suitable bidders to prepare and package of an application for subdivision of portion 136 of farm Loskop South 53 JS. The essence of the latter exercise is to subdivide the above said property into two (2) independent parcels of land. Portion 136 of farm Loskop South 53 JS hosts the Groblersdal water treatment plant and a Municipal house. The proposed subdivision seeks to detach the treatment plant from the Municipal house.

2. Executive Summary

The Development Planning and Local economic Development Directorate of Elias Motsoaledi Local Municipality has prioritized the subdivision of portion 136 of farm Loskop South 53 JS into two (2) distinct parcels of land. Ultimately, there has to be a parcel of land that hosts the Groblersdal treatment plant and the other hosting the Municipal house.

2.2 Quality Control and Quality Assurance

The Development Planning and Local Economic Development Directorate will oversee over work done by the prospective service provider in order to promote conformity with the Geomatics Profession Act (19:2013), reading together with section 65 of the Elias Motsoaledi Spatial Planning and Land Use Management By-Law (2016).

2.3 Health and Safety

The successful service provider must in conjunction with the Municipality must oversee that ethics and standards as outlined in the Geomatics Profession Act (19:2013) are upheld at all times during the undertaking of this exercise.
