- Moreover, once the area is clean, refastened the bolts to ensure that the roof is sound and stable.
- Coat the roof with an Etch primer to prevent any further rusting
- Waterproofed all the bolts independently and all the joints
- Seal the entire roof with two coats of good roof paint with a minimum of seven year guarantee
