#### **PRICING INSTRUCTIONS**

- a) These pricing instructions provide the tenderer with guidelines and requirements with regard to the completion of the pricing schedule. These pricing instructions also describe the criteria and assumptions which will be assumed in the contract to have been taken into account by the tenderer when developing his prices.
- b) The pricing schedule shall be read with all the documents which form part of this contract.
- c) The rates to be inserted in the pricing schedule are to be full inclusive for the work described under the specification. Such rates shall cover all costs and expenses that may be required in and for the execution of the work described, and shall cover the cost of all general risks, liabilities, and obligations set forth or implied in the documents on which the tender is based, as well as overhead charges and profit.
- d) A rate is to be entered against each item in the Schedule of Fees and Disbursements. An item against which no rate is entered will be accepted as a rate of nil having been entered against such items and covered by the other prices or rates in the schedule.
- e) All rates and sums of money quoted in the pricing schedule shall be in Rands and whole cents.
- f) All travelling costs, accommodation, meals and other incidental costs are to be included in the time based costs.
- g) Provisional amounts shall only be expended on the specific instruction of the Employer.
- h) All prices and rates entered in the pricing schedule must be inclusive of Value Added Tax (VAT).
- i) If VATregistered, then should be added below the schedule. If not VAT registered indicate zero or N/A
- j) Only firm prices will be accepted. Non-firm prices (including prices subject to rates of exchange variations) will not be considered.
- k) In cases of contract periods longer than 12 months and price adjustments is applicable, it will be based on CPI. If higher inflation is required indicate CPI + and number %.

## **SCOPE OF WORK**

#### SPECIFICATIONS/DESCRIPTION OF GOODS

- The mini-bar shall have at least one (1) flashing mode and incorporate a static "cruise" mode.
- The mini-bar shall have an extruded & anodized aluminium top & base.
- The lenses shall be manufactured from high impact resistant UV treated Polycarp.
- The mini-bar shall be low profile and aerodynamic for minimized wind drag.
- The mini-bar shall measure between 500mm & 600mm in length when measured from end cap to end cap and measure between 200mm & 300mm in width when measured from front lens to rear lenses.
- The mini-bar profile shall measure between 60mm & 70mm when measured from the base extrusion to the top extrusion. This will not include the mounting brackets and magnets.
- The mounting brackets shall be manufactured from 304 stainless steel and be powder coated. The brackets shall be made in such a way as to give adequate clearance between the roof of the vehicle and the underside of the mini-bar. The mounting brackets shall be fitted with four (4) magnets. Each magnet will have a pulling strength of not less than 90kg and be housed in a protective rubber boot.
- The mini-bar shall be constructed using all stainless fasteners (screws, nuts, bolts & washers) to avoid rusting.
- The mini-bar shall house the P. A., siren, amplifier and speaker driver.
- The siren, amplifier and speaker shall be 100 Watts and produce no less than 123 Db as per SAE J1849
- The mini-bar shall be fitted with a speaker trumpet to allow maximum sound output from the speaker. The speaker trumpet shall be injection moulded glass filled nylon.
- The mini-bar shall be fitted with 2 x rear facing and 2 front facing NEW GEN 6LED modules and no less than 2 x wide angle NEW GEN 3LED modules will be fitted to each side. The minibar shall emit light 360 degrees as per SAE J845.
- The mini-bar wiring harness shall be sheathed in a durable PVC sleeve and be fitted with a glassed fused cigarette lighter plug. The harness shall be fitted with a handheld controller incorporating the public address microphone and lights and siren controls. The controller shall be backlit illuminated for easy night time identification. Each button on the handheld controller shall be clearly marked with a non-removable print for easy function identification by the operator.
- The minibar shall automatically activate when any siren tone is activated. The ability to switch the minibar on without activating the siren must be incorporated. A silent function shall be incorporated whereby the siren can be deactivated with a single button press leaving the minibar on.
- The mini-bar shall have at least one (1) flashing mode and incorporate a static "cruise" mode.
- The Siren shall have the following warning tones.
  - 1. Wail,
  - 2. Yelp,
  - 3. Phasor.
  - 4. Air horn.
- The light bar & siren when in operation shall not exceed a current draw of 12.5 Amps @ 13.8VDC
- The unit shall have a warranty period of not less than three (3) years.
