The Council reserves the rights to either accept the whole or part of any bid, or not to appoint. Facsimiles or e-mail are not acceptable. All bids will be adjudicated in accordance with the 90/10 points system. All tenders shall hold valid for the period of 90 days. Bidders will be required to show compliance with the Preferential Procurement Policy Framework Act. Bidders with HDI, especially local content, women, disabled and youth would serve as an added advantage.
