- 2. Tenderers should have a CIDB grading of 3CE or higher.

Tender documents will be available **on 18 September 2013** at the Elias Motsoaledi Local Municipality Office in Groblersdal, and can be obtained on payment of a non-refundable amount of **R500.00** per bid document. Bank guaranteed cheques must be made payable to the Elias Motsoaledi Local Municipality.

- 9. Bidders will be required to show compliance with the Preferential Procurement Policy Framework Act 2011, **B-BBEE** Certification is a requirement.
